ECOWAS, WANEP Mark 15th Anniversary of UNSCR 1325

he Economic Community of West African States (ECOWAS) in partnership with the West Africa Network for Peacebuilding (WANEP) convened a meeting to commemorate the 15th Anniversary of the United Nations Security Council Resolution (UNSCR) 1325. The meeting with the theme; "15 Years of Implementing UNSCR 1325 in West Africa: Looking Back and Looking Forward" held from October 20 to 21, 2015 in Accra and was hosted by the Ghana Ministry of Gender, Children and Social Protection.

In his welcome remarks, WANEP Executive Director, Mr. Chukwuemeka Eze reaffirmed the critical role of women in promoting peaceful co-existence adding; "it is obvious that there can be no security where women are exposed to violence and no peace where they are ignored."



The Minister of Gender, Children and Social Protection Honorable Nana Oye Lithur, represented by the Deputy Minister, Honorable John A. Ackon, delivered the keynote address which detailed the role of Ghanaian women in peace building, especially their contribution to the Nkonya/Alavanyo peace process. Honorable Nana Oye Lithur who later declared the meeting closed, also reiterated the commitment of the Government of Ghana through her Ministry to promoting the women, peace and security agenda. She expressed optimism that gender equality in the region can be achieved through the collective efforts of all stakeholders and urged the participants to adopt outcomes of the deliberations as a call to action in fast-tracking the implementation of 1325 in their countries.

WANEP Takes Center Stage At African Union



n continuation of activities to mark the 15th Anniversary of the UN Resolution 1325, WANEP took center stage at the African Union Commission to share its contributions to the development of National Action Plans (NAPs) towards the implementation of the Resolution.

WANEP Program Director, Mrs. Levinia Addae-Mensah in her presentation informed the August gathering that the partnership between WANEP/ECOWAS and its member states' contributed significantly to the great milestones the region has achieved in the implementation of UNSCR 1325. "I make bold to say that no region on the continent has developed NAPs more than West Africa and in fact, the knowledge and application of UN-SCR 1325 in West Africa is gradually becoming the norm rather than the exception," she said. WANEP through the Women in Peacebuilding (WIPNET) programme has been promoting the women peace and security agenda using UNSCR 1325 and the ECOWAS Conflict Prevention Framework as guide and reference.

TALKING PEACE

From the outset, I want to underscore the value we attach to our partnership with various directorates in ECOWAS and specifically the Gender Directorate on this particular vision of localizing UNSCR 1325 in West Africa. ECOWAS continues to convince those of us from CSO of its keenness and willingness to truly transform itself to an ECOWAS of the people.

Fifteen years ago, the UN Security Council adopted resolution 1325 on Women, Peace and Security (UNSCR 1325) and National Action Plans (NAPs) to articulate the vision and ambition of countries to advance the protection, participation and empowerment of women and girls in different contexts. The Resolution marked formal international recognition, at the highest institutional level, of the importance of women to peacebuilding and of the necessity of adopting a gender sensitive approach to conflict resolution in order to meet women's needs.

Your Excellences, Distinguished guests, Ladies and gentlemen: Fifteen years into the implementa-

tion of UNSCR 1325 in West Africa, we are offered the opportunity to assess to what extent the resolution has made a difference in the lives of women across the region and how policies, processes and laws reflect a level of this positive change. "It is obvious that there can be no security where women are exposed to violence and no peace where they are ignored." Many women in our region still face real and immediate threats to their security and struggle for survival. And you don't have to look far away for an example. Look at the plight of the women and young girls in Sierra Leone over rape, think about the over 200 girls held hostage by insurgents in Nigeria, reflect on the effects of Ebola and the dire post effects on the women of MRU, imagine the percentages of women in governance in our respective countries, I can go on and on.

There must be a sustained leadership by a dedicated team to drive and coordinate the implementation of UNSCR 1325 National Action Plans as well as leadership and commitment from individual sectors and stakeholders to deliver success. I thank you all!

Program Director's Address at the AU PSC on WANEP's Work on UNSCR 1325

et me begin by thanking the leadership of the Peace and Security Council (PSC) and the African Union Commission (AUC) for this great honor and opportunity to share the WANEP-ECOWAS partnership on the implementation of UNSCR 1325 as an example of a strong CSO-Government–Inter-governmental Organization collaboration. I wish to also express WANEP's appreciation for the privileged space provided by ECO-WAS and it's Member States for WANEP's engagement through their relevant government institutions. Informed by the success of this kind of partnership, WANEP through a recently signed MOU is in discussion with the AUC to replicate same with other CSOs across the continent.

The WANEP – ECOWAS and its member states' partnership for the implementation of UNSCR 1325 has no doubt contributed to the great milestones the region has chalked. I make bold to say that no region on the continent has developed National Action Plans (NAPs) more than West Africa and in fact, the knowledge and application of UNSCR 1325 in West Africa is gradually becoming the norm rather than the exception.

The systematic engagement has contributed to significant progress made by West Africa on the development

of UNSCR 1325 Regional Action Plan and NAPs. Tangible achievements were made in the three pillars, namely prevention, participation, and promotion of the UNSCR 1325 with some countries including additional pillars – protection and prosecution in their NAPs. As a result, there has been increased engagement of women in the national peace infrastructures and mitigation of negative impact of high level of attrition rate within Women's/Gender Ministries. A database of trained women is in place awaiting the operationalization of the Mediation Center of ECOWAS.

A man of many parts and many accolades, Professor Albert was a co-founder and research Associate to the Center for Research on Inequality and Human Security (CRISE) at the University of Oxford, UK and was the Country Director of the Institute for Democracy in South Africa, IDASA at the Nigeria Office.

WANEP Burkina Board Chair Receives National Award

he Board Chair of WANEP Burkina Faso, Mr. Arouna SAVADOGO was elevated to the rank of Commander of the Order of Merit on December 11 on the occasion of the commemoration of the Independence celebration of Burkina Faso. This is the third national award for Mr. SAVADOGO. His other awards include Knight of the Order of Merit and Officer of the Order

of Merit.

This latest award was in honour of his activism, dedication and commitment to the national cause and for being at the frontline to oppose the amendment of Article 37 and the aborted putsch of September 2015. He also took an active part in the implementation of the charter of the transition period after the insurrection of October 2014. In accepting the award, Mr. SAVADOGO said it is in recognition of the resilience of the people of Burkina and the invaluable contribution of WANEP Burkina for the promotion and preservation of the culture of peace in the country.

WANEP At GPPAC

n its capacity as the Regional Secretariat of the Global Partnership for the Prevention of Armed Conflicts (GPPAC), WANEP participated in several meetings hosted by GPPAC in the last quarter of the year. The Board Chair of WANEP-Mali Oulie Keita represented WANEP at a GPPAC meeting on "Preparing a New Generation of Civil-Military Police Coordination for Human Security attended by about 70 representatives from peacebuilding civil society groups, UN, NATO, military and police training centers.

WANEP also participated in the GPPAC Working Group meeting on November 19 and 20, 2015 at the Hague. The meeting was to discuss the strategic context of peacebuilding and conflict prevention in the post-2015 period and identify opportunities for future co-operation and exchange.

Dr. Ibn Chambas Visits Election Situation Room

is Excellency Dr. Ibn Chambas, the Special Representative of the United Nations Secretary General and Head of the United Nations Office for West Africa (UNOWA) has commended the West Africa Network for Peacebuilding, WANEP for its efforts in supporting non-violent electoral processes in West Africa. The commendation came during Dr. Chambas' visit to the WANEP Election Situation Room in Conakry, Guinea on Guinean Election Day, October 11.

Dr. Chambas during the visit, encouraged WANEP to "keep up the good work of supporting non-violent electoral process through its election monitoring system." The WANEP Election Situation Room forms part of a larger civil society platform for monitoring the 2015 Elections in Guinea. WANEP was also part of the team of women in the UNOWA situation room while the regional staff at the WANEP Peace Monitoring Center, PMC followed keenly the voting process and provided regular updates on the WANEP social media platforms.

Dr Chambas also visited the WANEP Election Room in Ouagadougou, Burkina Faso during the elections on November 29.

Account Officers Trained On Financial Management Systems

A 2-day training on Financial Management Systems to enhance the capacity of Account Officers from all the WANEP national networks except Cape Verde, took place on October 14, 2015. The purpose of the training was to enhance WANEP's Probity and Accountability within the network offices and to harmonize one accounting software in both WANEP Regional and Network offices.

The training provided participants with the skills on the accounting software (Tally) and enabled them to prepare Entries, Print reports, Create Vouchers, Create Chat of Accounts among others. At the end of the training participants were expected to use the software to improve the Accounting and Administrative Department of their networks. The uniformed accounting software, Tally, enables effective supervision of the national offices accounts to ensure probity at all times. The training has led to improved financial regulations, timely reports and enhanced donor confidence in WANEP.

Stakeholders Hold National Dialogue for Peaceful Elections in Burkina Faso

A sthe leading civil society organization for peace and security in West Africa, the West Africa Network for Peacebuilding, WANEP has been monitoring and analyzing elections and electoral processes in West Africa for over a decade. WANEP operates under the undergirding philosophy of collaborative approaches to Peacebuilding, which is aimed at creating an enabling electoral environment before, during and after the elections.

In preparation for the November 29, 2015 general elections in Burkina, WANEP set up a Situation Room where the electoral proceedings were effectively monitored, analysed and reported. Prior to the elections, WANEP held a national dialogue with over 50 stakeholders in partnership



with the National Commission for Reconciliation and Reforms (CNRR) in Ouagadougou, Burkina Faso aimed at promoting peaceful and credible elections in the country. The dialogue served as a forum for all stakeholders involved in the electoral process to discuss and proffer solutions to ensure the peaceful conduct of the presidential and legislative elections as well as foster national reconciliation in the country.

AU-WANEP Hold Working Session

ANEP and the African Union Commission in November 2015 signed a historic Memorandum of Understanding (MOU) in support of the Commission's peace and security agenda as enshrined in the Africa Peace and Security Architecture (APSA). The MOU provides WANEP and CSOs the platform to support and contribute to peace and security debate on the continent. In this regard, the two organizations held a meeting in the Commission's office on the operationalization of the MOU.

This is in line with the principles of the Livingstone Formula as well as the aspirations within the WANEP 2015-2020 Strategic Plan. A key outcome of this MOU is the request by the Commission for WANEP to assign a Liaison Officer to the African Union Commission tailored along the WANEP Liaison Officer to ECOWAS. WANEP is also working with the Commission to explore and exploit the contribution of the Business Community to peace and security on the continent.

...Courtesy Visits to Key Stakeholders



WHO WE ARE

The West Africa Network for Peacebuilding (WANEP) was conceived in 1996 but formally launched in 1998. At the international level, WANEP has a Special Consultative status with the United Nations Economic and Social Council (ECOSOC) and is the West Africa Regional Representative of the Global Partnership for the Prevention of Armed Conflict (GPPAC).
